

Our Savior's Lutheran Church—Council Minutes September 21, 2025

Council members present: Pastor Liz, Tom Christensen, Terri Heimerman, Betty Consoer, Ginny Grabow, Jim Grabow. Betty provided a devotional.

Financial report: Brian Block presented the July financials:

The general fund received gifts of \$10,187.00, versus last year of \$8,980.00 giving us a difference of 1,207.00 The checkbook balance is \$9,748.49. Year to date, the General Fund received gifts of \$82,303.26 versus last year of \$80,365.45, giving us a difference of \$1,937.81. The financial report was approved on a motion by Ginny seconded by Tom/approved.

A decision on Pastor's health insurance plan needs to be made by October 14. Pastor Liz will study the plans available to determine which plan will meet her needs. We will vote at our meeting on October 5. The minutes of the August meeting was approved via email; was published in the September newsletter.

Old Business:

- Carpet Cleaning of hallways; fellowship hall was done in August (On the Spot Cleaners).
- Parsonage roof: On hold until spring Tom filed a complaint concerning the bankruptcy of Boelter and the loss of our deposit with Dept of Commerce; Dept of Labor; Industry. He contacted Emily Carson at the synod office and the bishop, who forwarded it to synod legal counsel. A report was filed with city. Filed a complaint to Pioneer Bank concerning how they handled this matter.
- **Discussion of trees and the rain garden maintenance.** The large maple tree south of the parsonage needs to be dropped by a professional. Perhaps congregational members could help remove branches. The rain garden is not functioning as a rain garden and has become an eyesore because it is not being maintained. A decision on this will be discussed in the future. Input from members appreciated.
- **Lawnmower** was donated by Kay Wendlschafer-only needs repair on the self-propelled feature. Terri Heimerman will see if her husband, Dean may be able to check it out and fix the problem. The two older sons of Kevin; Lacee Johnson have been mowing church property since August and are paid \$15 each per mowing.
- Altar painting-will be done over the winter by Sue Eppmeyer. Materials provided by Joanie Eppmeyer.

New Business:

- Events Calendar-some adjustments were made.
- Fall Stewardship-focus on all aspects of stewardship, not just offerings.
- Discussion of several events that happened lately
 - Initial meeting of God squad with Ice cream social, children were signed up with parent's consent.
 - VBS-numbers of participants was down, perhaps due to other activities for kids offered at the same time. We may look at earlier dates next year.
 - o God's Work Our Hands—28 students were served Lunch for a Buck

Jim moved we adjourn seconded by Betty. Meeting adjourned. Next meeting date October 5, 2025, after worship. Meeting closed with The Lord's Prayer. Ginny Grabow, council secretary

Members of Our Saviors Lutheran Church;

As many of you are aware the contractor, Boelter Siding and Window, hired to reroof the parsonage has been foreclosed on by their bank and subsequently filed for bankruptcy. This event occurred a few short weeks after they were awarded the project, and were paid the required 50% down.

In an effort maintain transparity and to keep everyone informed I would like to make you aware of the entire process, and update you on where we are currently.

During the June 8th '25 OSLC council meeting it was decided to proceed with having the parsonage house reroofed and gutter guards added to the eaves. Soon after I began the process of contacting area contractors to look at project and submit estimates. 3 of the 4 contractors contacted submitted estimates, estimates were reviewed and compared, then I contacted council members and church Treasurer indicating the potential cost of the project. It was determined at that time, per congregation bylaws, a congregational meeting would need to be held to review and vote on the project, per bylaws the announcement of congregational meeting was posted.

Congregational meeting occurred on July 28th '25, members present were given information of bid estimates, potential additional expense should sub-roof need replacement, and asked to approve up to \$30,000.00 for the project. Also, members present were made aware of intention to award project to Boelter as they were the contractor that roofed church 2 years ago and that project went very well. Motion and second received, members present voting proceeded that, and congregational approval was received.

After approval I contacted the sales representative of Boelter to meet, that meeting occurred on Aug. 10th '25, reviewed estimate to ensure no changes were expected, and informed them they would be awarded project. Contract was signed by both parties they were presented with a check for 50% of project estimate, \$9605.00.

On Aug. 29th '25 I was contacted by an acquaintance who asked if I had heard that Boelter had been foreclosed on and all equipment etc. seized by the bank, I immediately attempted to contact sales person who did not respond. On Aug. 30th '25 I drove to Boelter business site, all vehicles, equipment including office equipment were gone and the site appeared vacant. On Sept. 2nd I contacted church treasurer to see if payment could be stopped on deposit check, it was determined that the check had already been deposited into Boelter's account. Later that week local news media reported Boelter closing its doors.

Actions taken thus far in an attempt to receive our deposit monies back;

Boelter's bank has been contacted in person twice, copies of contract and deposited funds presented to them, and a claim filed with bank to get deposit money back. Bank has not responded to date.

A claim has been filed with the MN Dept. of Labor and Industry.

A criminal complaint has been with local law enforcement.

MN Dept. of Commerce contacted to file a claim in the "Contractor Recovery" department, this process includes language indicating efforts made in the small claims court system. The synod bishop has been contacted to request assistance from synod legal department in this area.

Lastly our insurer has been contacted to see if the church has any type of coverage in this area, no word on that yet.

For the time being council has decided to wait until spring of '26 to revisit this project. Funds received from members thus far will be held for this project, council greatly appreciated all whom have contributed. While this entire event has caused considerable heartache and frustration to our congregation, as well as many others in the area communities, I pray we will eventually see some if not all our funds returned. I will Trust in the Lord.
